Renewals as per the Knitters' Guild NSW Inc. Constitution 2024:

Subscriptions: (8b) The annual subscription shall fall due and payable in total on 1st January each year.

Unfinancial Members: (12) Any members whose annual subscription falls into arrears shall thereupon cease to be a member but shall be reinstated if the subscription in arrears is paid within one month of the due date of that subscription. Any member paying an annual subscription after one month of the due date of that subscription must also pay the current joining fee.

Note: It is necessary to be a financial member before nominating, seconding or accepting nomination for the Executive Committee or Group Committees. Members not renewing must submit their resignation in writing.
